As per Rating Rational of CARE Ratings, the downward revision of Rating of AT 1 Perpetual Bonds (Outstanding & proposed) and change in outlook from "Credit watch with developing implication" to "Negative" is attributed to likelihood of continuing asset quality pressure due to COVID-19 pandemic induced economic slowdown.
