### Bids for demolition of chimney at Jharsugudah power plant site

Authorised Officer of HUDCO, Indian Bank, Edelweiss ARC & PNB, the Joint Lenders invite bids for demolition of chimney at Jharsugudah (Odisha) power plant site for the **Account of M/s. - ii) Bid must accompany earnest money deposit (EMD) of 3% of quoted price by way of NEFT/ECS in the following account

The Bid without EMD will be considered as unresponsive and will be rejected.

- iii) Upon confirmation of receipt of EMD amount in the above account, the technical bid shall be opened and after qualifying technically, the financial bid will be opened.
- iv) The rates quoted, should clearly specify whether it is inclusive of all applicable taxes/duties. if so, at what rate? In case, this information is not indicated in the quotation, it would be presumed that the rates quoted are inclusive of all type of taxes/duties.
- v) Any modification in offer after the opening date will not be considered.
- vi) Bidder, before submitting bids, should clearly understand the requirement and, in case, any information/clarification is required, he / she may visit HUDCO (Bhubaneswar office), Indian Bank(Bhubaneswar branch), Edelweiss ARC (Mumbai office) & PNB(Jharasuguda branch) office during working days (Monday to Friday between 10 a.m. to 6 p.m.). It may be noted that no clarification/information after closure of the last date of receipt of bid, would be entertained.
- vii) Any modification in the bid after the opening date will not be considered.
- viii) Bid received late will not be considered. Lenders will not be responsible for any postal delay.
- ix) During Technical / Financial bid evaluation, Lenders may ask for any additional information.
- x) It is to be noted that evaluation of bids will not be based on any conditions.
- xi) Bidder should enclose brief information of the organization and the

- services undertaken by them for having an idea of quality of work done by them.
- xii) After award of work, if at any point of time, the work done is found unsatisfactory on account of not matching with the specification laid down or as per requirement of Lenders, the services would be cancelled and no further bills would be processed for payment by Lenders.
- xiii) The agency has to provide services at Jharsuguda.
- xiv) All statutory compliance such as Insurance cover, Pollution clearance (if applicable) etc, with regard to the work to be carried out shall be ensured by the bidder before commencing the work at site.
- xv) Lenders shall make payment of bills after deduction of all applicable taxes.
- xvi) Decision of Authorised Officer of Lenders shall be final and binding on both the parties in respect of all matters of dispute arising out of this bid.
- xvii) Lenders reserves the right to reject any or all bids without assigning any reason.
- xviii) Lenders will not be responsible for any damage, third party claims, litigations, accidents, fires, penalties, etc. The bidder shall pay to the workers as per minimum wages act and shall be fully responsible for his PF & statutory payments.
- xix) The chimney (as is where is) at power plant site in Jharsugudah is to be demolished/partially demolished (as the case may be) within a period of 1 month from the date of issue of work order.
- xx) There is no power connection/ availability of water at site for carrying out the job. Bidder will have to arrange the generator set / water tankers at their own cost. However agency working at site for lifting of plant & machinery has availed temporary electricity connection and had made the tube-well in working condition. Bidder may obtain temporary electric supply / water from them on chargeable basis as per their mutual consent.
- xxi) Bidders will have to take all safety measures during the demolition of the chimney to avoid any untoward incidents (if any).
- xxii) EMD @3% of quoted amount to be deposited via NEFT/ECS in the following bank account:

- xxvi) EMD amount shall be confirmed/converted as security deposit (without any interest) for successful bidder and for unsuccessful bidders, the amount will be returned (without interest).
