## Sub: Loan accounts in the name of M/s. Amsam Spinning Mills Private Limited with Indian Bank, Ramnagar Branch subsequently transferred to Stressed Assets Management Branch, Coimbatore.

**M/s. Amsam Spinning Mills Private Limited** has availed credit facilities from Indian Bank, Ramnagar Branch, the repayment of which are secured by mortgage of schedule mentioned properties, hereinafter referred to as 'The Properties'. **M/s. Amsam Spinning Mills Private Limited** has failed to pay the outstanding to the Bank. M/s. Amsam Spinning Mills Private Limited and others failed to make payment despite the above referred demand notice.

As M/s. Amsam Spinning Mills Private Limited and others failed to make payment despite the above referred demand notice, the Authorized Officer of Ramnagar Branch took possession of the scheduled mentioned properties under the Act on 07.12.2018 after complying with all legal formalities.

As per Sec.13 (4) of the Act, the Secured Creditor is entitled to effect sale of the assets taken possession of and realize the proceeds towards the outstanding balance. In accordance with the same, the authorized officer intend selling the schedule mentioned securities by way of E auction mode.
