Notice of intended sale under Rule 6 (2) & 8 (6) of The Security Interest (Enforcement) Rules 2002 under The Securitization and Reconstruction of Financial Assets and Enforcement of Security Interest Act 2002.

Sub: Loan accounts in the name of A/c Ms.Revathi and Manikandan with Indian Bank, Vadavalli Branch subsequently transferred to Stressed Assets Management Branch, Coimbatore.

Ms.Revathi and Manikandan availed credit facilities from Indian Bank, Vadavalli Branch, the repayment of which are secured by mortgage of schedule mentioned properties, hereinafter referred to as 'The Properties'. **Ms.Revathi and Manikandan** failed to pay the outstanding to the Bank. Therefore, a Demand Notice dated 29.08.2015 under Section 13(2) of the Securitization and Reconstruction of Financial Assets and Enforcement of Security Interest Act 2002 (for short called as 'The Act') was issued by the Authorized Officer, calling upon Ms.Revathi and Manikandan and other liable to the Bank to pay the amount due to the tune of **Rs.36,28,508.20 (Rupees Thirty Six Lakhs Twenty Eight Thousand Five Hundred and Eight and Paise Twenty Only) as on 28.08.2015** with interest, cost, other charges and expenses thereon. Ms.Revathi and Manikandan and others failed to make payment despite the above referred demand notice.

As Ms.Revathi and Manikandan and other failed to make payment despite the above referred demand notice, the Authorized Officer took possession of the scheduled mentioned properties under the Act on 24.11.2015 after complying with all legal formalities.

As per Sec.13 (4) of the Act, the Secured Creditor is entitled to effect sale of the assets taken possession of and realize the proceeds towards the outstanding balance. In accordance with the same, the authorized officer intend selling the schedule mentioned securities by way of E auction mode.

As per Rule 6 (2) and 8 (6) of the Security Interest (Enforcement) Rules 2002 framed under the Securitization

and Reconstruction of Financial Assets and Enforcement of Security Interest Act 2002, 30 days notice of intended sale is required to be given and hence we are issuing this notice.

NOTICE

The amount due as on 17.02.2019 is Rs.39,17,607.18 (Rupees Thirty Nine Lakhs Seventeen Thousand Six Hundred and Seven and Paise Eighteen only) with further interest, costs, other charges and expenses thereon.

Please take note that this is notice of 30 days and the schedule mentioned properties shall be sold under the act by the authorized officer any time after 30 days.

The date of sale is fixed as **27.03.2019** which would be by e- auction mode.

The schedule mentioned properties, related documents and up to date EC can be verified / inspected by the intending purchasers / bidders at their expense on **11.03.2019 between 10 AM to 5 PM** at Indian Bank, Stressed Assets Management Branch, 1st Floor, 31, Variety Hall Road, Coimbatore-641 001. The Reserve Price and Earnest money Deposit (EMD) for the sale of secured assets are fixed as mentioned in the schedule.

The last date for submitting tenders/bids complying with all necessary terms along with EMD in the stipulated manners is **26.03.2019 by 5 PM.**

The tenders should be accompanied with EMD remitted through RTGS / NEFT / Account transfer and / or any other acceptable mode of money transfer without time lag, failing which the tender becomes disqualified.

The sale shall be conferred on the person making highest offer/ tender / bid subject to confirmation by Secured Creditor. The Authorized Officer reserves right to accept or reject the bid / tender without assigning any reason whatsoever.

Once the auction/ e auction is completed and sale is conferred on the person making the highest offer / tender /bid, the successful bidder will be intimated in person /by e mail, as the case may be, who has to remit 25 % of the bid amount (less EMD) immediately by way of **RTGS / NEFT / Account transfer and / or any other acceptable mode of money transfer**, failing which the EMD amount remitted will stand forfeited.

The balance sale price shall be paid within 15 days of the confirmation of sale or extended time in writing. If the balance amount is not remitted within the stipulated / agreed time, the amount of 25 % remitted will also stand forfeited. On payment of the balance sale price as mentioned above, Sale Certificate will be issued in the name of the Successful bidder and it is the responsibility of the Successful Bidder to get the said Sale Certificate registered before Sub Registrar Office by paying the applicable stamp duty and registration charges.
