01	Page No.6 of 63 – Clause No.2.0 – There is no clarity on which minimum wages to follow. Since the Bank is Government of India Enterprises, we have to follow the Central	Minimum Wages Act to be followed, Central or State Govt. wages whichever is higher.
	Minimum Wages Act or because the Bank is situated in Tamil Nadu, we have to follow Tamil Nadu Minimum Wages Act.	It is the responsibility of the contractor to pay minimum wages to their employees as per extant guidelines and the rate should be quoted covering any such revision. IMAGE/BANK will not entertain any request for increase in rates.
02	Page No.10 of 63 – Clause No.5 – "IMAGE is not bound to accept the lowest Tender" – Kindly clarify whether IMAGE has prefixed any reserve price without disclosing it and any offer is received less than the prefixed price, the IMAGE would not accept even the quote is L-1.	We have not prefixed any reserve price.  For other clarifications, please refer Point No.5 of page 3 of 63.
03	Page No.14 of 63 — Clause 1.1.1 — Sub Clause d) Cleaning Material: The clause says that the material procured and provided by the contractor and the Bills of the items	Cost of consumables will not be reimbursed. As regard to actual quantity required, the bidders who were taken around IMAGE complex on 30.03.2019 should assess the quantum of consumables requirement.
04	Page No.15 of 63 – Clause 1.1.4 – Regarding maintenance of 3 pump sets by the contractor – Please clarify whether actual cost of spares, lubricants and other consumables for the maintenance of the 3 pump sets shall be reimbursed on production bills.	Cost of spares, lubricants and other consumables for the maintenance of 3 pump set will be reimbursed by IMAGE on production of bills.
05	Page No.16 of 63 — Clause No.1.2 — Kitchen/Catering Services in The Guest House: Sub-clause 1-4 - Kindly clarify whether the food preparation for the Guests staying at the Guest House might be prepared at the Trainees' kitchen (irrespective of different menu) and be served at the Guest House which would minimise the cost of food at the Guest House.	
06	Page No.17 of 63 – Clause No.2.12 – What exactly the clause means? Please clarify.	Please refer clause 2.11 of Page 17 of 63. (On special occasions like parties to be conducted at guesthouse or in any of the Bank's chosen place, the Contractor shall be ready to undertake such parties.

07	Page No.19 of 63 – Clause No.1.4.2 – Kindly clarify whether cost of spares/consumables shall be reimbursed by IMAGE, during the routing maintenance of all the electrical installations and plumbing	Cost of spares/consumables will be reimbursed by IMAGE on production of bills.
08	Page No. 21 of 63 – Point No. 1.5.3 of 1.5 – Laundry Services – Whether IMAGE will provide space for keeping the Laundry Machine since it is mentioned that IMAGE shall provide water and electricity along with adequate space	No. IMAGE will not provide space for keeping the laundry machine.
09	Page No.24 of 63 – Clause No.12 – This clause indicates the total requirements of contractual workers are 71 for smooth running of the work. But there is bifurcation for each category such as Catering, Housekeeping and gardening. Also there is no mention about the relievers – for 71 crews as much as 12 relievers are required.	As far as, IMAGE is concerned the requirement is 71 workers as specified in the Tender Document. So, it is up to the contractor to work out the modalities for the same in compliance with applicable laws of the land.
10	Page No.27 of 63 – Clause 35 – Kindly clarify whether the services of the Carpenter is need and call basis.	Please refer Annexure IV- Sr. No.34 of page 54 of 63 wherein carpenter is included as one of the staff required.
11	Page No.27 of 63 – Clause 36 – Kindly clarify whether the services of Pest Control is in the scope of contractor or reimbursement basis.	It is under the scope of contract and hence it will not be on reimbursement basis.
12	Page No.48 of 63 – Annexure I (i) Schedule of catering rates – The financial Bid indicates that the Bidder to quote for lump sum amount per day per Trainee/Guest. It means there is no need for separate quoting each items such as bed-tea/coffee, Breakfast, Mid-morning Tea, Lunch, Evening Tea/Coffee, Snacks and Dinner. Kindly clarify, how the contractor would bill, if a Trainee/Guest leaves after taking bed-tea/coffee, breakfast and skipping the remaining part the day's menu. Please clarify.	the remaining part the day's menu, Contractor should claim only the actual rate for which the trainee had their food and not the full rate.
13	Sir, there is no mention about the acceptance of MSME Registration in lieu of EMD. We enclose a copy of MSME Schemes, which indicate the benefits for the Bidder registered with MSME. We further have to bring to your kind notice that all the State/Central Institutions/training centres are extending exemption for payment of EMD for the Bidders registered with MSME. We, therefore, request you to kindly consider the acceptance the copy of MSME registration in lieu of EMD.	As per extant guidelines of Government of India, exemption from payment of EMD will be considered, provided valid documents are attached along with Technical Bid i.e. validity of registration as on the date of entire tender process should be ensured.
