Reply to the queries during Prebid meeting held on 12.07.2019 of bidders.

Sno	Query raised by the bidders	Bank's Reply
01	Whether Empanelment with MNRE is mandatory to participate in the Tender?	As per MNRE's notification dated 23.12.2017,empanelment of channel partners under the Grid Connected Rooftop and Small Solar Power Plants has been discontinued. Hence, it is not mandatory for the bidder to be in the approved list of MNRE to participate in the tender.
02	Is valid EA license issued by the Tamil Nadu Electrical Inspectorate necessary to participate in the Tender?	Yes, Valid EA license (HT/LT) is necessary to execute Electrical works in Banks Branches. However, the Tenderers may submit EA license of other approved contractors which should be duly approved by Bank.
03	Is companies registered under Udhyog Aadhaar/ NSIC exempted from submitting EMD & Tender Fee?	Yes. The companies registered under Udhyog Aadhaar/ NSIC are exempted from submitting EMD & Tender Fee. They are required to attach a copy of valid Registration certificate.
04	Whether change in minimum eligibility criteria for participation in Tender is allowable?	No, Tender condition as mentioned in Eligibility Criteria (Clause 5, Page 5) holds good.
05	Whether modification in the minimum bill amount for Rs 50,00,000/- (Rupees Fifty Lakhs) possible?	Bank will entertain only one running bill per month for a minimum gross amount of Rs 45,00,000/- (Rupees Forty Five Lakhs). All other payment terms are as per Tender.
06	Whether reduction in the processing time for bill payment possible?	No, Tender condition holds good.
07	Clarity regarding the rectifications pointed out by CEA / CEIG / TEDA/TANGECO/other govt agencies.	If the rectifications pointed out by Govt agencies is pertaining to the installed Solar Power Plant by the contractor, it will be in the contractor's scope of work. If the rectifications pointed out by Govt agencies is pertaining to Bank's premises, it will be in the scope of Bank.



08	Whether delay due to CEA/CEIG, Liquidated Damages will be levied upon?	No. However only after the project approval from govt agencies /installation of Net meter the amount quoted by the bidder in the tender shall be released.
09	Whether internet connection for Online Monitoring will be provided by Bank?	Yes. The internet connection shall be provided by Bank.
10	Whether water source nearer to the Solar Panels for cleaning will be provided by Bank?	Yes.
11	Regarding testing and inspection of invertor and panels.	The Inspection & Testing of Invertor and Solar panels shall be done by Bank if necessary at the testing facilities in India.
12	Whether localised maintenance set up is required?	Yes, Tender condition holds good.
13	The options for brands mentioned in DC cabling.	Tender condition / list already given holds good.
14	Regarding Site condition.	Bidders are requested to visit the site before quoting the price as each site has its own characters in location.
