








Such clause will discourage any Bidder to go ahead with the Bid where there is no guarantee on the investment and may incur huge losses. Bank may terminate the Bandwidth with a notice period of 180 days. However, we request Bank to either remove the termination for convenience clause for leased Equipment (Rental) completely or agree to pay the remaining/balance future rental period payments from the effective date of termination.
