## NOTICE OF INTENDED SALE

Mr. Pal Singh and Mrs. Neelam availed facilities from Indian Bank, Saharanpur Branch, the repayment of which are secured by mortgage of schedule mentioned property hereinafter referred to as "the Property". Borrower and others liable to pay failed to pay the outstanding, therefore a Demand Notice dated 15.03.2017, under Sec 13 (2) of Securitization and Reconstruction of Financial Assets and Enforcement of Security Interest Act 2002 (for short called as "The Act"), was issued by the Authorised Officer calling upon the borrower and others liable to the Bank to pay the amount due to the tune of Rs. 11,81,479/- (in words Rupees Eleven lakh eighty one thousand four hundred seventy nine only) as on 14.03.2017, with further interest, costs, other charges and expenses thereon, the borrower and others liable to pay failed to make payment despite Notice dated 15.03.2017.

As the borrower and others liable to pay failed to make payment despite Demand Notice, the Authorised Officer took possession of the schedule mentioned properties under the Act on 14.03.2019 after complying with all legal formalities.

As per Sec.13 (4) of the Act, Secured Creditor is entitled to effect sale of the assets taken possession of and realize the proceeds towards outstanding balance.
