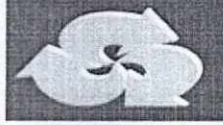

Both the above envelopes marked as "Technical Bid" & "Financial Bid" shall be kept in a third sealed envelope super-scribing on top as "Offer for _____ Branch Premises" and name, address & contact number of the offerer at bottom left corner should be addressed to Asstt. General Manager, Zonal Office, Jai Stambh Chowk Satna. The said sealed envelope is to be submitted with the Zonal Office with due time and date for submission for offers, as detailed in this "Ad". The offer/Application contained in 3rd envelope as detailed in above paragraph is to be submitted at the Zonal Office at address mentioned within 06:00 PM, 10.08.2020. The offer/application shall be dropped in the box kept for the purpose at Zonal office on or before due date and time.
