CONDITION OF CONTRACT

1. Scope of work:

The work comprises of supply, installation, testing and commissioning of Ductable & Non-ductable split air-conditioning units by the vendor at the site. The system offered by the vendor shall guarantee the inside design conditions (75 + 2 FBD & RH 55%) at all o through out the year.

2. Technical Catalogues:

Technical Catalogues of the indoor and outdoor units shall be submitted along with the quotation showing (i) Technical details (ii) Dimensions of units and (iii) Guaranteed Power Consumption unit.

3. Electrical Work:

- (a) Evaporator unit shall be sleek having air filter which can be removed and cleaned easily and provided with wired remote control consol having on/off fan speed and temperature control function.
- (b) Unit shall have self contained Electrical panel with necessary accessories such as relays, contractors wire as per latest Indian standards.
- (c) MCB with switch and metal clad socket shall be provided by the owner near each Evaporator Unit, necessary copper cabling interconnecting. MCB, and Evaporator Unit and Evaporator and Condensing Unit shall be carried out by Vendor.

4. Rates:

Vendors shall offer the system inclusive of all taxes and duties such as Works Contract Tax, Sales Tax, octroi, Excise Duty, etc. GST will be extra as applicable

6. <u>Completion Period</u>:

The work is to be completed in all respect in one Month from the release of the order/letter of intent.

7. Terms of Payment:

The payments shall be made in the following manner.

90% against supply, installation, commissioning and on virtual completion of works.

100% against performance Bank Guarantee for defects liability period of one year after commissioning.

8. Guarantee and Defects Liability:

The vendor shall guarantee that all equipments shall be free from any defects due to defective materials and/or bad workmanship and the system shall provide the inside design conditions. The guarantee shall be valid for a period of 12 months from taking over or 18 months from the date of last delivery of materials, whichever ends earlier.

During the guarantee period free quarterly preventive maintenance and breakdown calls shall be replaced and also loss of refrigerant shall be replaced by vendor.

9. <u>After Sales Service</u>:

Vendor shall provide prompt after sales service and should have inventory of necessary spare parts and machine components such as compressors etc. On receipt of a breakdown call from the owner the vendor shall carry out the installation within 24 hours.
