5.	-	Warranty - Is Apple warranty needs to be quoted or third party warranty can be incorporated. The major difference in Apple warranty and third party warranty would be that third party warranty will be applicable only within the geographical boundaries of the country(India). For eg: If the user is travelling abroad and something happens to the iPad then warranty can't be claimed under third party. Rest everything remains the same. AppleCare Enterprise - For getting the ACE activated there is a minimum bench mark from Apple is of 200 units under warranty. So the current RFP has 145 units to get qualified for ACE programme, Bank needs to have at least 55 units under warranty then ACE programme can be initiated.	Warranty for the iPads and accessories to be provided as defined in the RFP. Further, Bank is having more than 55 ipads under warranty as on date.
