#### Terms & Conditions for participating in the Tender:

- 1. Last date of Submission of sealed quotation /Tender is: 28.02.2023, 03:00 Hours.
- 2. The date of quotation /Tender opening will be: 28.02.2023, 03:30 Hours.
- **3.** The Quotation specific Authorization Letter (mentioning the name of RFP Num) from OEM or Manufacturer is required for participation in process. The authorization letter should be addressed to **Indian Bank Zonal Office, Varanasi**.
- **4.** The quotation should be accompanied by the Certificate of OEM/Authorized Dealers/ Authorized Suppliers otherwise the bid is liable to be rejected.







- 5. The selected venders are required to supply and install the batteries in the individual branches as per requirement within 4 days from the date of order. If the vendor fails to deliver and/or install the batteries within mentioned time line i.e. 4 (Four days), bank will have the discretion to cancel or nullify the purchased order to L1 vendor and same be awarded to other vendor who agreed to L1 rates.
- 6. Invoice must contain serial number of all batteries installed at each branch. All the serial numbers of each battery installed at branch will be verified from concerned OEM regarding genuiness and validity of warranty. After receiving satisfactory report from OEM only payment will be released.
- 7. Terms and conditions for warranty should be clearly specified and any complaint should be resolved within 24 hrs for Urban/Semi Urban from the time of lodging complaint
- **8.** In case of Battery failure during warranty period, the vendor has to replace the batteries at their own cost in 3 days.
- **9.** The vendor has to replace the entire set of batteries within a week, in case of multiple failure occurs during warranty period
- 10. Bank reserves the right to reject any or all the quotations and stop the process at any point of time without assigning any reason whatsoever
- 11. Vendors should have valid GSTN number and GST Registration No. should be clearly mentioned in the quotation, failing which the tender will be rejected.
- **12.** The Bank may procure SMF batteries with buyback of SMF batteries of any specification / rating and vice-versa.
- 13. Ineligible / Incomplete tenders are liable for rejection
- **14.** Extra GST will be applicable as per I.T Act. Other extra charges such as Transportation charge, Installation charge etc. will not be included after delivery.
- 15. Bidders are advised to see the proposed sites/Branches premises before quoting their rates
- 16. In case of failure to take up the work even after accepting the work order, or leaving the work incomplete, or for defective work not rectified, or violation of the terms and conditions, the Bank may take suitable action against the contractor as appropriate.
- 17. In case of any dispute, the matter will be referred to the Zonal Manager, Indian Bank, Zonal Office Varanasi.

All the serial numbers of each battery installed at branch will be verified from concerned OEM regarding genuiness and validity of warranty. After receiving satisfactory report from OEM only payment will be released.
