

1. Please bring copy of the call letter issued.
2. Please bring the following certificates and testimonials **in original without fail** along with one set of **photocopies** of the same in the following order duly **self-attested**:
 - a. Printout of this Call Letter with your photograph affixed thereon
 - b. System generated printout of the online application form
 - c. Proof of Date of Birth (Birth Certificate or SSLC/ Std. X Certificate with DOB)
 - d. Photo Identify Proof & Address proof
 - e. Mark sheets & Certificates for educational qualifications.
 - f. **Experience certificate** - Please note that for the present as well as previous employment, for each position held experience certificate(s) need to be produced to the satisfaction of the Bank. The same should be specific and explicit experience certificates containing details of full name, full address and telephone numbers of the employers, period of experience with exact dates, designation held, nature of duties performed, number of persons reporting to you, nature of projects handled.
 - g. Caste Certificate for candidate belonging to SC/ ST/ OBC (Non-Creamy Layer) and EWS category certificate issued by competent authority should be as per the prescribed format notified by Government of India.
 - h. Disability certificate (wherever applicable) in prescribed format issued by the District Medical Board in case of Persons with Disability category.
 - i. An Ex-serviceman candidate has to produce a copy of the discharge Certificate / pension payment order and documentary proof of rank last / presently held (substantive as well as acting) at the time of interview.
 - j. Candidates serving in Government / Quasi Govt.
