Stage 2:

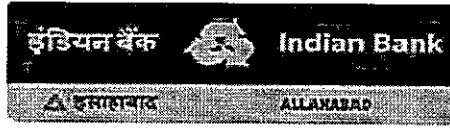

TERMS AND CONDITIONS FOR SALE OF BANK'S OLD USED CAR

1. The disposal of vehicle shall be strictly on "AS IS WHERE IS AND WHATEVER IS BASIS" and no guarantee or certificate of its worthiness or quality will be given by the Bank. The condition of the vehicle can be inspected physically between 1100 to 1700 hrs on any working day between 08.05.2024 to 21.05.2024 at Indian Bank, Zonal Office, 92 Civil Lines, Jhansi 284001, Uttar Pradesh.
2. Bidders need to submit earnest money for Rs. 5,000/- and application fee Rs 100/-. The earnest money and application fee is to be submitted as DD payable at Indian Bank, Jhansi. If the highest Bidder/ successful Bidder fails to deposit the sale price within the prescribed time limit, his earnest money will be forfeited. In case the offer is withdrawn by any Auctioneer, the earnest money deposited by him shall be forfeited. Offers received without EMD amount shall not be considered at all by Bank.
