#### **Stage 2:**

Qualified bidder shall participate in the online e-Auction for the purchase of old Bank's Car which they wish to purchase.

### **TERMS AND CONDITIONS FOR SALE OF OLD CAR**

The condition of the vehicle can be inspected physically from 16.05.2025 to 30.05.2025 (except holidays) between 1100 hrs to 1600 hrs on at Indian Bank, Zonal Office, Madurai, 100-101 East Avani Moola Veedhi, Madurai - 625001.
2. Bidders need to submit earnest money for Rs. 5,000/- and application fee Rs 100/-. The earnest money and application fee is to be submitted as DD payable at Indian Bank, Madurai. If the highest Bidder/ successful Bidder fails to deposit the sale price within the prescribed time limit, his earnest money will be forfeited. In case the offer is withdrawn by any Auctioneer, the earnest money deposited by him shall be forfeited. Offers received without EMD amount shall not be considered at all by Bank.
