# Subject: Updates regarding Revision in Benchmark Rates and complete waiver of minimum balance charges levied in SB Account

In terms of SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, we have to inform you that the Asset Liability Management Committee (ALCO) of the Bank has reviewed the Marginal Cost of funds based Lending Rate (MCLR), Treasury Bills Linked Lending Rates (TBLR), Base Rate, Benchmark Prime Lending Rate (BPLR) and Repo Linked Benchmark Lending Rates (RBLR) and decided for downward revision in MCLR, TBLR, Base Rate and BPLR across various tenors, as detailed below:

Further, the Asset Liability Management Committee (ALCO) of the Bank has also approved for complete waiver of minimum balance charges levied in Saving Bank Accounts for non maintenance of stipulated Minimum Balance for customers having Saving Bank Accounts with our Bank effective from **07.07.2025**.
