- Sealed quotation is to be submitted within the above stipulated time and date to the Asst. General Manager, Indian Bank, FGM Office, 04th floor, Kolkata 700 106
- 8. Rates quoted shall be inclusive of all Taxes, Levies, Duties and Transportation and Service Tax etc. Goods and Service Tax (GST) shall be paid to the contractors as per applicable rules subject to submission of proper GSTIN.
- Rates shall be quoted in both figures and words. Quotations shall be submitted in the prescribed schedule, duly signed and sealed in all pages. In case of any discrepancies in the rate quoted in figures and words and in the amount, the rate quoted in words in original will be considered.
- 10 Contractors shall provide all labor and material including necessary scaffolding for proper execution of the work including curing etc.
- 10% of the final bill value will be retained as security deposit and will be refunded on satisfactory completion of free maintenance period, i.e., one year from the date of completion of work. No Interest shall be paid.
- Rates quoted shall be inclusive of providing necessary arrangements for satisfactory protection of furniture / electrical fittings / Bank's any other property during execution of the work.





- Rates shall be inclusive of cost for disposing debris and any other unserviceable materials as per materials as per direction.
- Rates shall be inclusive of cleaning of floors, making good to damaged floor, ceiling, walls, etc., after completion of work.
- In case of any poor quality of work or substandard materials used for the purpose shall be replaced as per instructions without any extra cost.
- Should the wok be not completed to the satisfaction of the Employer/Consultant within the stipulated period, the contractors shall be bound to pay to Employer a sum calculated@ 1% of the accepted contract sum per week of delay subject to maximum of 10% of the accepted contract value by way of liquidated damage and not as penalty during which the work remains un-commenced or unfinished after the expiry of the completion date.
- 17 The Bank shall have the right to change the quantities and specifications as per on spot requirements. Decision of engineer-in-charge will be final and binding.
- The contractors / suppliers should study the drawing/layout plan thoroughly and may visit the site prior to quoting their rates for the above work and should strictly adhere to tender specifications.
- 19 Quantities are approximate and the work will be paid on the measurement basis as per ISI Code of Measurement.
- 20 Evidence vouchers from manufactures/ authorized agents showing use of proper materials should be furnished as and when required.
- 21 The date of commencement of work will be considered after 3 days from the date of issuing of work order or the date of handling over of site/work-front to the contractors, whichever is later.
- If rate against any item is found low compared to market rate/estimated rate, Bank may insist Performance Bank Guarantee for the same of any Nationalized Bank other than Indian Bank and its group of banks.
- The bidder is advised to visit the site before quoting the rates. The job has to be carried out without hampering normal working of the Branch and on holidays.
- All the relevant papers including this paper must be signed and sealed by the bidder and to return with quotation.
- Existing furniture shall be utilized as per direction of site –in-charge or consultant. Rate shall include shifting (from other floors of same building) & modification of existing furniture. Bidder shall visit the site and acquaint themselves before submission of offer.
