- **1.** This invitation to limited tender is for Maintenance of UPS of different makes and models, which are being used by Indian Bank in the Branches/ Offices under Jaipur Zonal office.
 - The specimen contract mentioning terms and conditions is as per Annexure 'A'.
 - The Scope of Work is as per Annexure 'B'.
 - The list of location is as per Annexure 'C'.
 - Tentative quantity of hardware as per Annexure 'D'
 - Performa for Commercial Bid as per Annexure 'E'

2. <u>ELIGIBILITY CRITERIA</u>:

A. <u>Services</u>:

i. The bidder should have minimum of 5 years 'experience in the Maintenance of UPS and must be performing the AMC (UPS) of at least Three years in Public Sector Banks. (Proof to be submitted along with technical bid). (Copy of Order to be submitted).

ii.Bidder should have registered/ Permanent office in Jaipur for the last five years.

- iii.Bidder is required to have at least 5 service locations across the Rajasthan state especially in Jaipur, Sikar, Alwar, Shriganagnagar and Bikaner or nearby center of aforesaid cities but not more than 50 Km away from these centres. The bidder should have necessary infrastructure & service support centres for maintenance of offered UPS. The bidder should be capable to provide efficient and effective support so as to attend calls at all branches and offices under Jaipur Zone with in stipulated time frames mentioned in this RFP.(Proof to be submitted along with technical bids). The bank will analyze the number of service centers, number & position of engineers at centers, infrastructure etc. of all the vendors/bidders as a part of minimum qualification criteria. If the Bank is not satisfied with the number of service centers, number & position of engineers at service centers, infrastructure etc, Bank reserves the right to technically disqualify the vendor(s). The decision of the Bank shall be final.
- iv. Necessary proof of having office infrastructure located at Jaipur and service centers should be submitted along with tender document.
- v. The bidder should be capable of providing multivendor OEM support i.e. capable of providing service & support of UPS of Techser/Numeric/Hitachi/Consul/Synergy/BPE/Tritronics or equivalent make or any maker.
- vi. The bidder should be a company/Firm/Sole proprietary concern incorporated in India having an average annual turnover of Rs. 1.00 Cr in last three financial years (2022-23

and 2023-24 and 2024-25) as per the audited balance sheet available at the time of submission of tender in providing the support services (Sale and purchase will not be applicable). This must be individual turnover and not that of any group of company/Firm/Sole proprietary concern. Copy of incorporation certificate/Partnership Deed and Registration Certificate/PAN Card and Audited Balance Sheet need to be submitted as applicable to the bidder. Wherever the word company is reflected, it will include Firm and Sole proprietary concern as a bidder. Copy of incorporation certificate and Audited Balance sheet or Certificate issued by CA for last three financial years need to be submitted.

- vii. The bidder should have made operating profits in the last three financial years.Copy of Audited balance sheet and Profit & Loss A/c or Certificate issued by CA for last 3 consecutive years.
- viii. The Contract cannot be sublet and vendor needs to provide support through its own staff only.
- ix. If bidder has already given similar kind of services in Indian Bank Jaipur Zone earlier ,satisfactory performance certificate from Indian Bank Zonal office Jaipur should be submitted.
- **B.** Successful bidder have to submit the Performance Securities (in the form of BG from a nationalized Bank), for an amount of 10% of the order value of the Purchase Order, valid up-to 60(Sixty) days beyond the date of contract period at zonal office Jaipur.
- **C.** The bidder should not have been blacklisted by any of Government Authority or Public Sector Undertaking (PSUs) as on date of submission of bid. The bidder shall give an undertaking (on their letterhead) that they have not been blacklisted by any of the Govt. Authority or PSUs as on date of submission of the tender.
- **D.** The tender offer should be submitted, in one sealed envelope super-scribed 'Tender for UPS in Indian Bank', which in turn should contain separately sealed covers super-scribed as "Technical Bid and Commercial Bid".
- **E.** Each page of tender form must be numbered, duly signed and Sealed by bidder as a token of acceptance of all the terms and conditions set out in the tender document. The entire tender document (Except Annexure 'F') must be sealed in the envelope marked as Technical Bid. Only Annexure 'F' must be sealed inside the envelope marked as Commercial Bid.
- **F.** Documents to be submitted along with Technical Bid:
 - (a) Documents to prove eligibility as per clause 2A.
 - (b) Tender fee in the form of Demand Draft of Rs. 500+ GST.
 - (c) All the papers of tender duly sealed and signed by the company/firm except Commercial Bids.

G. The bidder must provide customer satisfaction letters from at least three Public Sector Banks where the bidder has provided services in last 3 financial years. (Proof to be submitted along with technical bid).

H. Bidder must be ISO 9001 certified with validity till 30.06.2025 (Attach the certificate copy as proof). In case the aforesaid certificate expires before 30.06.2025. The bidder must provide a renewed certificate post renewal. Failure to provide the renewed ISO 9001 certificate will result in termination of services.

I. Vendors having franchise arrangement of 3rd party service support cannot quote. The minimum engineers should be fifteen on the Company's pay roll. Submit undertaking on letter head and relevant & authenticated proof of engineers having on Company's payroll.

J. The bidder should have minimum 30.00 Lakh UPS AMC Order in Rajasthan annually.

K. The sealed commercial bid should be submitted in cover 'Commercial Bid for maintenance of UPS at Indian Bank' as per format in Annexure 'F'.

L. Sealed cover 'Technical Bid' and 'Commercial Bid' placed in a single envelope duly sealed, super- scribed 'Tender for Maintenance of UPS at Indian Bank' and addressed to 'Zonal Manager, Indian Bank Jaipur Zone should be submitted at the below mentioned address not later than 3 p.m. on 10.07.2025. - V. If it is evasive or incomplete including non-furnishing of the required documents.
- VI. If it is without the Tender Fee (Demand Draft/ Banker's Cheque)

5. VALIDITY OF TENDERS

Tenders should be valid for acceptance for a period of at least 90 (ninety) days from the last date for submission of bids. Offers with lesser validity period would be rejected. Once a rate is accepted/ negotiated the same would be valid till expiry of AMC.

13. PERFORMANCE GUARANTEE

The successful bidder/s will have to furnish a performance guarantee to the tune of 10% of the value of the PO for proper fulfillment of the contract. This performance Guarantee shall be released on the expiry of the period of AMC agreement.

14. AMC AGREEMENT

The successful bidder will have to enter into a contract with the Bank as per Annexure 'A', with an option with the Bank to extend the contract, for a further period of one year or less, on the same terms and conditions. If the Contract is extended, bidders have to submit the Performance security (BG) upto the extended period.

- 1. This Tender Document is not transferable.

 - This procedure is subject to changes and if so, the procedure adopted by the Bank, for opening the tender shall be final and binding on all the parties.

UPS MAINTENANCE AGREEMENT

SCOPE OF AGREEMENT

This agreement made on this day of between hereinafter called the "BIDDER" and INDIAN BANK, hereinafter called "Bank" sets forth the terms and conditions for the maintenance of Hardware equipment as specified in Annexure 'D'.

1. TERMS AND CONDITIONS

A. OBLIGATIONS OF THE BIDDER:

- i. The Bidder shall provide the following service to keep the equipment in good working condition.
 - a. The Bidder shall carry out scheduled preventive maintenance, and same will be submitted to zonal office along with the invoice copies.
 - b. The Bidder shall also be responsible for any unscheduled on call corrective and remedial
 mointenance convices to get right the malfunctions of the UDS

maintenance services to set right the malfunctions of the UPS.

- ii. The Bidder shall attend on call services within 8 hours (in case of major cities like Jaipur, Alwar, Bikaner, Bharatpur, SIkar) and 24 hours (in case of rural centers) of lodging a complaint and get any error or fault corrected within the stipulated hours, thereafter If the call is not attended so in stipulated time suitable penalty can be imposed by the Bank and the same can be deducted from the ensuing AMC bill/s.
- iii. The Bidder shall not sub-contract or permit any third party other than the Bidder's personnel to perform any work, service or other performance required of the Bidder under this agreement without the prior written consent of Bank.
- iv. If the UPS supplied are not attended for repair or problems are not rectified within the time frame mentioned in Annual Maintenance Contract, the Bank would get such defective machines repaired by some third party, and the amount spent for such repairs would be billed to the Bidder.
- v. The Bidder shall submit consolidated report furnishing the details of breakdown calls attended and its status on weekly basis.
- vi. The bidder should have centralized number and email id to lodge the complaint that can generate Complaint number. The escalation matrix for resolution of complaints would be provided.

- vii. The Bidder shall identify and provide one Engineer as resident engineer who will be a single point contact for coordinating and providing services to the offices and its company. RE will maintain the record of call lodged and status of complaint lodged.
- viii. If bidder has already given similar kind of services in Indian Bank Jaipur Zone earlier ,satisfactory performance certificate from Indian Bank Zonal office Jaipur should be submitted.
- ix. The bidder should not have incurred losses during the last 3 Financial Years and Average Annual Turnover (For previous 3 Financial Years) should be minimum 1 Cr Rupees. This must be individual company turnover and not to be any group of company. (self-attested copy of CA Certificate with UDIN number should be submitted).
- x. The Bidder shall make AMC services available on all working days of bank as and when requested by the Bank.
- xi. Bidder/UPS AMC Vendor will not provide quotation for purchasing the Batteries for Branches and Offices under Jaipur Zone.

B. OBLIGATIONS OF THE BANK

- i. The Bank is to ensure that as far as possible, power source and dust free environment are provided to sites where UPS are installed.
- ii. The Bank would intimate to the Bidder, if any additional attachments, features or devices are to be directly or indirectly, connected to the equipments.
- iii. The Bank would ensure that rats, insects etc., do not invade the site and damage the systems, especially cables etc.

2. ENHANCEMENT/UPGRADATION OF EQUIPMENT

The Bank shall have the right to make changes or attachments to the equipments provided such changes or attachments do not prevent proper maintenance from being performed, or unreasonably increase the Bidder's cost of performing repair and maintenance services. Wherever, any changes or enhancement in the equipment, results in an adjustment of maintenance charges, the same, shall be payable from the date of installation of additional features/enhancement.

Individual items or equipment can be added to or withdrawn from Annexure 'D' by the Bank. In the event that individual items or equipment are added to Annexure 'D', it may involve additional maintenance charges. In the event that individual items of equipment are withdrawn from Annexure 'D', as described herein, then any amount prepaid on such equipment shall be

3. WORKING HOURS

The maintenance services shall be rendered on all days subject to the Bank's requirement to keep the equipment in good working condition and order. The service consists of corrective and preventive maintenance and includes carrying out of necessary repairs to the installed equipment.

4. RELOCATION OF SYSTEMS

During the maintenance agreement in force, the Bank may relocate the system and keep the Bidder informed. In case of relocation of equipment, transport and other incidental charges will be borne by Bank. The list of branches provided at annexure 'C' is therefore an indicative list of present branches. The Bank may, in future, decide to open more branches and in turn decide to relocate the Hardware elsewhere; the hardware so shifted would be covered by this contract.

5. EXTENSION OF MAINTENANCE PERIOD

If the Bidder does not attend to each breakdown and malfunction of UPS supplied within the time specified in clause A (ii) of the agreement and make all efforts to rectify the same and get the UPS in proper working condition within seven days thereafter, the maintenance period shall be extended by a period equal to number of days taken to set right the system.

6. EXCLUSIONS

The maintenance agreement does not include:

- Electrical work external to the equipment or maintenance of accessories, i. attachments machines or other devices.
- ii. Furnishing platens, accessories, paintings or refinishing the machines or furnishing the materials thereof, making specific changes.
- Work done for alteration in the equipment by persons other than the Bidder's personnel iii. (except for minor rectification by Bank's in house systems engineer after intimating the Bidder)
- Any work external to the equipment such as maintenance of non-Bidder attachments, iv. accessories etc.

7. VALIDITY OF AGREEMENT

This agreement is valid for a period of 12 months from the date of signing of contract and submission of Performance security (BG) with an option with the Bank to extend the contract for a further period of One Year or less on the same terms and conditions.

8. CANCELLATION

Either party by giving one month's notice in advance, may terminate the agreement prior to expiry of contract period. The AMC charges will be paid on proportionate basis.

9. JURISDICTION/ARBITRATION

In case of any dispute or any difference arising at any time between the parties in respect of this agreement, the same shall be resolved by mutual discussion and if not resolved then in accordance with and subject to the provision of the Indian Arbitration Act 1940 and only Courts of the Jaipur shall have jurisdiction in all matters arising out of or connected with this agreement. Further, this agreement is subject to laws of India only.

10. **PENALTY**:

In case any requirement is not made usable/repaired within stipulated time specified in Annexure A, terms & Condition clause (ii) the company will be required to arrange for an immediate replacement of the same failing which the company will be liable to pay a penalty of Rs 100/- for each item per day which will be realized from the AMC charges payable or from the company directly. The penalty not exceeding 10 % of AMC cost for the affected unit.

11. FORCE MAJEURE:

The Bidder shall not be liable for any delay or failure of performance of any of its obligations under or arising out of this contract, if the failure or delay results from any of the following Act of God,

refusal of permissions or other Government Act, fire, explosion, accident, industrial dispute and the like which renders it impossible or impracticable for the Bidder to fulfill its obligations under the contract or any other cause or circumstances of whatsoever nature beyond Bidder's control.

12. LIABILITIES & INDEMNITIES :

The Bidder represents and warrants that the repair and maintenance of services/products hereby sold do not violate or infringe upon any patent, copyright, trade secret or other property right of any other person or other entity. The Bidder agrees that it will and hereby does, indemnify the Bank from any claim, directly or indirectly resulting from or arising out of any breach or claimed breach of this warranty.

13. CONFIDENTIALITY

The Bidder acknowledges that all materials and information which has or will come into its possession or knowledge in connection with this agreement of the performance, hereof, consists, of confidential and proprietary data, whose disclosure to or use by third parties will be damaging or cause loss to Bank. The Bidder agrees to hold such material and information in strictest confidence not to make use thereof other than for the performance of this agreement, to release it only to employees requiring such information, and not to release or disclose it to

any other parties. The Bidder shall take appropriate action with respect to its employees to ensure that the obligations of non-use and non-disclosure of confidential information under this agreement are fully satisfied.

SCOPE OF SERVICE

Annexure 'B'

Indian Bank, Zonal Office Jaipur intends to enter into a comprehensive AMC for UPS of different makes, installed in offices under branches of Jaipur Zonal office. The objective of this RFP is to enter into rate contract with one or more bidders for maintenance of UPS available in branches and offices. Bank and selected bidder/s would enter into an agreement for the period from 01.08.2024 to 31.07.2025 who will submit the bids for AMC with following scope.

The Scope of the Work is defined as under:

- 1. The scope of work includes but not limited to comprehensive on-site maintenance of UPS.
- 2. The replacement of all the spares like logic board, capacitors, Mother boards etc and consumables are covered/included under the AMC. The replacement of defective spares with genuine spares of same configuration will be done without any extra cost.
- 3. The vendor shall maintain adequate spare machine and other spares in their office to facilitate any temporary replacement.
- 4. The scope of work also includes periodical checking UPS health, input and output voltage level of UPS and Batteries, Voltage levels of earthing.
- 5. Thebiddershallmaintaintheequipment'saspermanufacturer'sguidelinesandshalluse standard and genuine components for replacement.
- 6. In case of tubular batteries, engineer must pour distilled water in batteries as and when required. Charges for purchasing water will be borne by Bank.
- 7. It is the responsibility of the vendor to collect asset details at the beginning of the contract and to maintain the inventory. In case, if any asset is missed out from the AMC contract, the vendor should attend the call for those assets and can include those assets for next payment. If there is mismatch of serial numbers of the asset, the asset serial number scan be rectified at later stage without any delay in attending the calls.
- 8. During installation of UPS under AMC, all connected equipment like Stabilizers and batteries should be installed even if the said equipment doesn't come under AMC. However, peripherals which are both in inoperable condition and not under AMC may be excluded.
- 9. Complaints can be registered either telephonically or by e-mail by respective branch/Office and proper record of the complaints to be maintained by the firm.
- 10. On Administrative requirement in future Bank may shut any of the branch/offices, UPS and Batteries at those locations may be utilized at other offices and will be included in AMC through different location.
- 11. The Bidder will have to take AMC on comprehensive basis i.e. the Bidder has to take care of all

- 12. Comprehensive AMC will exclude the Burn cases, Physical Damages only. All other parts will be covered under Comprehensive AMC. All such activity is to be recorded and submitted at ZO on monthly basis.
- **13**. Half yearly preventive maintenance of hardware devices. Preventive maintenance (including inspection, testing, and satisfactory execution of all diagnostics will be done every half yearly in addition to the normal maintenance required as per this agreement and submit the PM report to Zonal office.

14. Payment Terms- The AMC payment shall be made on completion of every quarter by this office, vendor have to submit invoices to the our offices with preventive maintenance report. Payment will be released after satisfactory service. Billing will be based on actual Hardware available in the branch.

15. The bidder have to provide complete Hardware Inventory (both branch wise and consolidated) within the 15 days from the starting of AMC contract and 15 days prior to the ending of AMC period from all the branches in the Banks agreed format.

16. No charges will be payable for the movement of engineer from one location to another for attending to service calls.

17.If selected, the Bidder shall have to submit and sign an Annual Maintenance Contract as per

Annexure 'A' on a Stamp Paper of appropriate amount.
