SECTION III

CONDITIONS OF CONTRACT

DEFINITIONS

In this contract, the following terms shall be interpreted as indicated:

- a. **"The Contract"** means the agreement entered into between the purchaser and the supplier, as recorded in the contract form signed by the parties including all the attachments and appendices thereto and all documents incorporated by reference therein;
- b. **"The Contract Price"** means the price payable to the supplier under the contract for the full and proper performance of its contractual obligations;
- c. **"The Goods"** means all of the equipment, machinery, and / or other materials which the supplier is required to supply to the purchaser under the contract;
- d. **"The Services"** means those services ancillary to the supply of the Goods, such as transportation and insurance, and any other incidental services, such as installation, commissioning, provision of technical assistance, training and other such obligations of the supplier covered under the contract;
- e. **"The Purchaser"** means Indian Bank.
- f. **"The Supplier"** means the company supplying the Goods and Services under this Contract.
- g. **"The Project Site"**, where applicable, means the place of delivery of equipment's.

1. Scope of Bid

- 1) Vendor has to provide onsite AMC support for following hardware at Desktop PCs and computer peripherals such as Scanners and Printers for 51 branches, Zonal Office, RAC, RAPC, MAPC, Currency Chest etc. and any new branches to be opened under Zonal Office Bhopal.

AMC vendor has to provide maintenance for operating systems, installation or re- installation of operating systems, installation of application software required/instructed and provided by bank (MS-Office, Biometric software, etc), installation and configuration of peripherals like Printers, Scanners as required by the Bank and support on remote assistance, configuration/installation, maintenance, Service, shifting of these assets etc. whenever required.

2) The vendor will be required to provide support in operating system installation or re-installation, installation of application software as required by the Bank from time to time & require assistance in data recovery, pre-emptive action against virus detection/removal (For All PC's and other peripherals with or without warranty). AMC vendor should keep sufficient spares at their office and on approval for replacement, vendor should provide replacement parts including motherboard, hard disks, power supplies, memory, monitors, other accessories/spares for peripherals etc. within next working day. Change of spares should be done only after taking prior approval from EDP/IT Dept.

3) The vendor should respond to a site visit and commence repair work on the equipment within 6 hours of being notified of equipment malfunction. If the systems could not be rectified on first visit, standby systems with equal or higher configuration should be provided on next working day. If standby system is provided, then the faulty system must be repaired or replaced with equal or higher configuration within 2 working days excluding the day of reporting.

4) The vendor should provide onsite support services of one engineer (seated at our Zonal Office) to attend /to support calls immediately and adequate number off field engineers, 2 persons should be available for attending to the requirements/calls on all working days. In case of exigencies/absence of any of the Onsite/off field Engineers, immediate arrangement must be made to ensure Substitute Engineer is provided maximum by the next working day. **Two engineers provided by the vendor at zonal office/onsite support services should be at sole discretion of Zonal office/ as Suggested by our Zonal Office.**

5) The successful bidder has to perform physical verification of all the hardware covered under AMC for this RFQ and affix stickers (With Name of vendor, ABC period, Contact Details for call logging) on every PC & peripherals. A detailed Inventory list of every PC & peripherals across the branches to be prepared by the Vendor within first month of AMC tenure.

6) For PCs, Laser Printers, Passbook Printers, ADF Scanners under AMC for Hardware support, all the spare parts should be covered under AMC.

7) AMC for the printers should cover all parts including fuser assembly set except toner and plastic parts.

8) Quarterly one preventive maintenance service should be provided for the all PC's, Printers and Scanners with or without warranty and service report to be submitted along with the submission of invoice for the quarter. AMC vendor will have to log call for the system issues with the existing vendors of the Bank and ensure end to end follow up.

9) Based on re-assessment. the number of hardware items may be increased or decreased at the time of the contract or during the period of the Contract which may be included or excluded from the list. The assets can also be shifted from one location to another location and the vendor providing maintenance support shall continue the support for such items, on being informed by the Bank. In case of any change in quantity of Hardware, the successful bidder has to provide support at the same rate finalized in this RFQ.

10) If at any point of time, the services of vendor are not found to be satisfactory, the contract will be terminated by Bank, without any prior notice in advance.

11) Bank has proposed to short list at least 2 vendors L1 & L2. In case of poor customer service by L1, if a branch/office raises complaints about service and support bank may terminate the contract without any prior notice and the AMC for rest of period of contract may be given to the L2 vendor. Payment of the AMC amount will be done on prorated basis for the period for which the vendor's support was taken by the bank.

12) AMC Support through sub-contracting will not be accepted. If at any point of time during the contract, if engagement of sub-contractor is identified, Bank reserves the right to terminate the Contract, without assigning any further reason, whatsoever.

13) The vendor should have minimum three years of experience in the maintenance of computer systems and relative field with Large Nationalized Banks / Financial Institutions/Public Sector Units within the state of Madhya Pradesh. Necessary document like PO or WO in support of experience to be submitted with the contact details.

14) The Firm should not have incurred losses during the last 3 financial years.

15) No person associated/employed with the company should have any police case/complaint filed against him for any cyber/computer related crime.

16) The bidder should not have been blacklisted by any Public Sector Bank/PSU's/de-empaneled in the past. A self-declaration letter by the bidder, on the Company's letterhead must be submitted.

17) No charges will be payable for the movement of engineer from one location to another location for attending the service calls.

18) No charges will be payable for carrying the spares/equipment's/faulty devices from site to Bidder's work and back to bank.

19) AMC Vendor should support installation/repair of any Computer or Computer related Hardware Peripherals moved from one branch to another branch.

20) If any new branches are opened which are not covered under AMC, the AMC Vendor should support as per the agreed rate.

2. Penalty

In case any support call is not attended and rectified/repared within the stipulated time as specified in RFQ, the vendor will be required to arrange for replacement or standby of the same, failing which the vendor will be liable to pay a penalty of Rs.500/- per day which will be deducted from the subsequent payments to the vendor.

3. Terms of Payment

The payment will be released quarterly (at the end of the quarter) on submission of invoice along with quarterly preventive maintenance service report and call reports pertaining to the quarter by the vendor.

4. Confidentiality

The vendor will be exposed to internal business information of the Bank, affiliates, and / or business partners by virtue of the contracted activities. The Bidder / their employees shall treat all data & information collected from the Bank during the project in strict confidence. The Bank is expected to do the same in respect of Bidder provided data / information. **After termination of the contract also they should not divulge any data / information.**

5. Limitation of Liability

Vendor's aggregate liability under the contract shall be limited to a maximum of the contract value. This limit shall not apply to third party claims for

- IP Infringement indemnity
- Bodily injury (including Death} and damage to real property and tangible property caused by vendor's gross negligence. For the purpose for the section, contract value at any given point of time, means the aggregate value of the purchase order placed by bank on the vendor that gave rise to claim, under this tender.

6. Bank's right to accept or reject any bid or all bids or rate contract

Bank enforces the right to accept or reject any bid, and to annul the bidding process and reject any/all bid/s at any time prior to award of Contract.

If the service provided by the vendor is found unsatisfactory or if at any time during the period of contract it is found that the information provided for the contract or any claim is false or if irregularities shown by the vendor for applying for the contract, the Bank shall reserve the right to cancel the contract and remove such vendors from the contract without giving any notice to the vendor.

7. Negotiation

The Bank reserves the right to further negotiate on the price offered, with the L1 vendor, if the price quoted is found unreasonable or in any exceptional circumstances.

8. Disclaimer

The Bank and/or its officers, employees disown all liabilities or claims arising out of any loss or damage, whether foreseeable or not, suffered by any person acting on or refraining from acting because of any information including statements, information, forecasts, estimates or projections contained in this document or conduct ancillary to it whether or not the loss or damage arises in connection with any omission, negligence, default, lack of care or misrepresentation on the part of Bank and/or any of its officers, employees.

9. Indemnity Clause

If at the time of bidder/vendor supplying, installing the Hardware/Software and Support in terms of the present contract/order or subsequently it appears at any point of time that an infringement has occurred of any patents, trademarks or other rights claimed by any third party, then in respect of all costs, charges, expenses, losses and other damages which the Bank

may suffer on account of such claim, the service provider shall indemnify the Bank and keep it indemnified in that behalf.

10. Patent Rights

The Service provider shall indemnify the Bank against all third-party claims of infringement of patent, trademark or industrial design rights arising from use of the Goods or any part thereof.

11. Period of Validity of Bids

Quote shall remain valid for the period of 90 days after the last date for submission of bid prescribed by the Bank. A quote valid for a shorter period shall be rejected by the Bank as non-responsive. Bank may seek extension of bid validity, if required.

12. Settlement of Disputes

- a.If any dispute or difference of any kind whatsoever shall arise between the Bank and the service provider in connection with or arising out of the contract, the parties shall make every effort to resolve amicably such disputes or difference by mutual consultation.
- b. If after 30 days the parties have failed to resolve their disputes or difference by such mutual consultation, then either the Bank or the service provider may give notice to the other party of its intention to commence arbitration, as hereinafter provided, as to the matter in dispute, and no arbitration in respect of this matter may be commenced unless such notice is given.
- c. Any dispute or difference in respect of which a notice of intention to commence arbitration has been given in accordance with this clause shall be finally settled by arbitration. Arbitration may be commenced prior to or after delivery of the goods under the contract. Submitting to arbitration may be considered as an additional remedy and it does not preclude the parties to seek redressal/other legal recourse.

Arbitration proceedings shall be conducted in accordance with the following rules of procedure.

The dispute resolution mechanism to be applied shall be as follows:

(a) In case of dispute or difference arising between the Purchaser and a Service provider relating to any matter arising out of or connected with this agreement, such dispute or difference shall be settled in accordance with the Arbitration and Conciliation Act, 1996. The arbitral tribunal shall consist of 3 arbitrators one each to be appointed by the Purchaser and the Service provider; the third Arbitrator shall be chosen by the two Arbitrators so appointed by the Parties and shall act as Presiding Arbitrator. In case of failure of the two arbitrators appointed by the parties to reach upon a consensus within a period of 30 days from the appointment of the presiding Arbitrator, the Presiding Arbitrator shall be appointed by the Indian Banks' Association, India which shall be final and binding on the parties.

(b) If one of the parties fails to appoint its arbitrator within 30 days after receipt of the notice of the appointment of its Arbitrator by the other party, then the Indian Banks' Association shall appoint the Arbitrator. A certified copy of the order of the Indian Banks' Association making such an appointment shall be furnished to each of the parties.

(c) Arbitration proceedings shall be held at Bhopal, India, and the language of the arbitration proceedings and that of all documents and communications between the parties shall be English.

(d) The decision of the majority of arbitrators shall be final and binding upon both parties. The cost and expenses of Arbitration proceedings will be paid as determined by the Arbitral Tribunal. However, the expenses incurred by each party in connection with the preparation, presentation etc. of its proceedings as also the fees and expenses paid to the arbitrator appointed by such party or on its behalf shall be borne by each party itself.

(e) Where the value of the contract is Rs. 10 million and below, the disputes or differences arising shall be referred to the Sole Arbitrator. The Sole Arbitrator shall be appointed by agreement between the parties; failing such agreement, by the appointing authority namely the Indian Banks' Association.

(f) Notwithstanding any reference to arbitration herein,

- a. the parties shall continue to perform their respective obligation under the contract unless they otherwise agree; and
- b. the Bank shall pay the service provider any monies due to the service provider.

Submitting to arbitration may be considered as an additional remedy and it does not preclude Parties to seek redressal/other legal recourse.

13.Applicable Law

Laws of India and any other guidelines having the force of law in India will be applicable.

14.Jurisdiction

Any dispute arising out of this order will be under the jurisdiction of Courts of law in Bhopal.

15. Termination for Convenience

The Bank, by 30 days written notice sent to the Service provider, may terminate the Contract, in whole or in part, at any time for its convenience. The notice of termination shall specify that termination is for the Bank's convenience, the extent to which performance of the Service provider under the Contract is terminated, and the date upon which such termination becomes effective.

16. Termination for Default

The Bank, without prejudice to any other remedy for breach of contract, by 30 days written notice of default sent to the Service provider, may terminate this Contract in whole or in part:

- a) if the Service provider fails to deliver any or all of the Goods within the period(s) specified in the Contract, or within any extension thereof granted by the Bank;
- or
- b) if the Service provider fails to perform any other obligation(s) under the Contract.
- c) If the Service provider, in the judgement of the Bank has engaged in corrupt or fraudulent practices in competing for or in executing the Contract.

'For the purpose of this clause:

"corrupt practice" means the offering, giving, receiving or soliciting of anything of value to influence the action of a public official in the procurement process or in contract execution; and

"fraudulent practice" means a misrepresentation of facts in order to influence a procurement process or the execution of a contract to the detriment of the Bank, and includes collusive practice among Bidders (prior to or after bid submission) designed to establish bid prices at artificial non-competitive levels and to deprive the Bank of the benefits of free and open competition.

In the event the Bank terminates the Contract in whole or in part, the Bank may procure, upon such terms and in such manner as it deems appropriate, Goods or Services similar to those undelivered, and the Service provider shall be liable to the Bank for any excess costs for such similar Goods or Services. However, the Service provider shall continue performance of the Contract to the extent not terminated.

17. Force Majeure

The Successful bidder shall not be liable for forfeiture of its performance security, liquidated damages, or termination for default, if and to the extent that, its delay in performance or other failure to perform its obligations under the Contract is the result of an event of Force majeure.

For purposes of this clause, "Force Majeure" means an event beyond reasonable control of the Successful bidder and not involving the Successful bidder's fault or negligence and not foreseeable. Such events may include, but are not restricted to, acts of the Bank in its sovereign capacity, wars or revolutions, fires, floods, epidemics, quarantine restrictions, and freight embargoes. Delay by sub suppliers of vendor to Vendor will not be considered as cause of force majeure.

If a Force Majeure situation arises, the Successful bidder shall promptly notify the Bank in writing of such condition and the cause thereof but in any case not later than 10 (Ten) days from the moment of their beginning. Unless otherwise directed by the Bank in writing, the Successful bidder shall continue to perform its obligations under the Contract as far as is reasonably practical, and shall seek all reasonable alternative means for performance not prevented by the Force majeure event.
