The disposal of vehicles shall be strictly on **"AS IS WHERE IS AND WHATEVER THERE IS BASIS"** and no guarantee or certificate of its worthiness or quality will be given by the Bank. The condition of the vehicles can be inspected physically between 11.00 hrs to 16.00 hrs on any working day between 19.11.2025 to 29.11.2025 at Indian Bank, Corporate Office, 254-260 Avvai Shanmugam Salai, Chennai-600014.

Bidders need to submit earnest money of Rs. 5,000/- per vehicle (Refundable) and application fee Rs 100/- (Non-Refundable). The earnest money and Application fee should be payable through **Demand Draft** only in favor of Indian Bank payable at Chennai, failing which the bidder will not be considered for further e-Auction process. If the highest Bidder/ successful Bidder fails to deposit the sale price within the prescribed time limit, his earnest money will be forfeited. In case the offer is withdrawn by any tenderer, the earnest money deposited by him shall be forfeited.

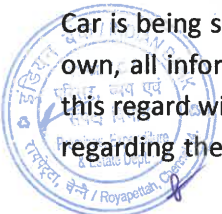
The delivery of the sold vehicle will be arranged only after the successful bidder submits name transferred Registration certificate in original for verification.

The sold vehicle will be shifted by the successful bidder(s) by depositing the money at their own expenses. No assistance/ transportation will be provided by the Bank. Permission to take out the disposed vehicles from Bank's premises will be allowed only on working days (between 11.00 hrs to 16:00 hrs).

Sale letter will be executed in favor of the Successful Bidder upon depositing the entire sale consideration. The successful bidder will also be responsible for getting the Registration Certificate of the vehicle transferred in his name at his own cost expeditiously in the concerned RTO. Bank will not be responsible for any lapse on his part in this regard. Delivery of the sold vehicle will be given only after production of Original Registration Certificate for the purpose of verification.
